

Valor Volleyball Club Waiver 2021-2022

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT/PHOTO RELEASE

I/We the undersigned hereby certify that I (we) am (are) the parent(s) or legal guardian(s) of the athlete. In consideration of participating in Valor Volleyball activities such as tryouts, training, camps, tournaments, etc., I (we) represent that I (we) understand the nature of these activities and that I (my child) am qualified, in good health, and in proper physical condition to participate in such training. I (We) acknowledge that if I (we) believe event conditions are unsafe; I (we) will immediately discontinue participation in the training.

I (we) fully understand that these activities involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by the athlete's own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the athlete named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I (we) fully accept and assume all such risks and all responsibility for losses, costs, and damages incurred as a result of my athletes participation in the training.

I (We) hereby release, discharge, and covenant not to sue Valor Volleyball Club, its owner, its coaches, Level A Sports facility, their respective administrators, directors, volunteers, employees, other participants, any sponsors, advertisers, and, if applicable, other owners and lessors of premises on which the training takes place, from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the athlete or otherwise, including negligent rescue operations; and I (we) further agree that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I (we), or anyone on our behalf, makes a claim against any of the athletes, I (we) will indemnify, save, and hold harmless each of the athletes from any loss, liability, damage, or cost which any may incur as the result of such claim.

Specific Covid-19 Issues

Valor Volleyball is doing everything in its power to protect the coaches and other participants in its activities. To this extent, we will be following the Center of Disease Control (CDC) and the State of North Carolina health department guidelines with regard to safe practices in order to reduce the spread of COVID-19. This will require our staff and participants to:

COVID-19 Health Protocols:

Signs will be posted at entrances and exits indicating Valor Volleyball is invested in following the correct health protocols. These signs will clearly state one cannot gain entry if you have COVID-19, are experiencing symptoms of COVID-19, or if you or any of your friends or family members have been exposed to COVID-19.

- All coaches, staff members, and players will have their temperatures taken prior to the beginning of practice.
- Spectators will not be allowed in the gym.
- All coaches and athletes must wash their hands upon entry.
- After cleaning their hands, players must place their bag and personal items in a designated area.
- Coaches will sanitize their hands prior to and multiple times during practice sessions.
- Players will sanitize their hands multiple times during their training session.
- At the end of the training session coaches and staff members will clean their assigned balls, ball carts and any other training equipment utilized.
- Bathroom facilities will be frequently sanitized and cleaned.
- There will be no sharing of water bottles during these training sessions.
- All athletes and coaches are required to wash and sanitize their hands after using the restroom, sneezing, coughing, and before participating in any training.

I (we) grant permission to Valor Volleyball the right to use photographs taken of the athlete for promotional use on its website, ValorVolleyball.com and/or its Facebook, Instagram, YouTube and/or Twitch pages. I (We) agree to release, defend, and hold harmless Valor Volleyball, its staff, directors, coaches, employees, representatives and successors from and against any claims, damages or liability arising from or related to the use of the photographs for promotional purposes.

I / we, the undersigned, understand and acknowledge that participation in a recreational training can be hazardous and I / we realize that no one should enter into a recreational training unless the participant is medically able.
